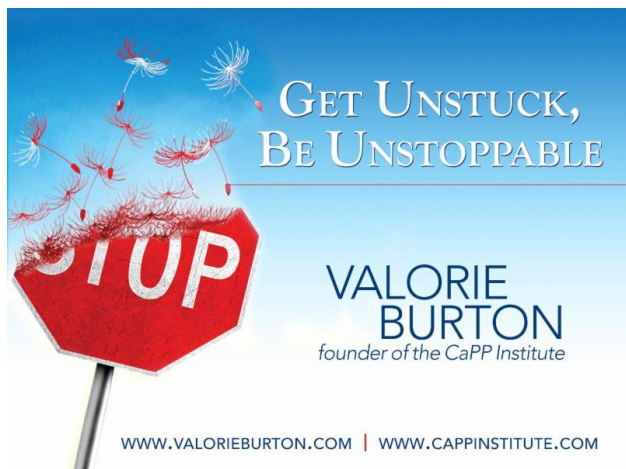

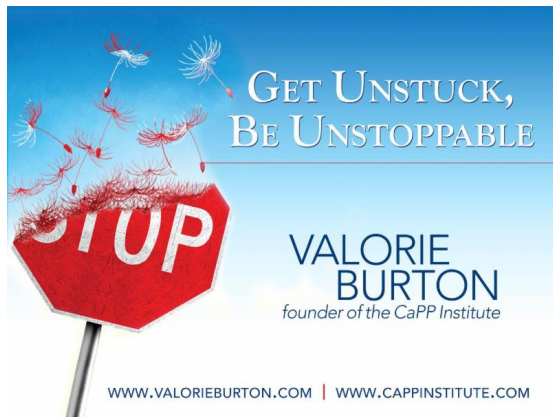
## A Note from the President...
