Membership Dues for 2020 are being collected. [Click here](#) to print off the form to submit with your payment. (ANEW is not equipped to accept credit cards. All dues must be paid by cash or check.) Members that join throughout the year are prorated to end December 31, 2019. ALL current members wishing to renew their membership for 2020 will be required to pay their dues by December 31, 2019. A \$15 late fee will be added to all dues postmarked January 1 thru Jan 31. A \$25 late will be added if postmarked after January 31st. Members not renewed by February 15th, 2020 must re-apply for membership at the full \$295 fee.
