In two short years the USA will celebrate our 250th anniversary. So, in the spirit of celebration, here are a few interesting facts pertaining to July 4th:

Declaration of Independence: July 4th commemorates the adoption of the Declaration of Independence by the Continental Congress in 1776, declaring independence from Great Britain.

Signing: While July 4th is celebrated as Independence Day, the actual signing of the Declaration of Independence did not occur on that day. Most of the delegates signed it on August 2, 1776. **Deaths:** Both Thomas Jefferson and John Adams, who were instrumental in drafting the Declaration of Independence, died on July 4, 1826, exactly 50 years after its adoption.
